Legal Language in Layman's Terms

EMPLOYER IDENTIFICATION NUMBER (EIN)

An EIN is a nine-digit number assigned by the IRS that serves to identify estates and trusts as separate taxable entities. The EIN allows the IRS to properly recognize and process the tax obligations of the estate or trust, treating it as an entity distinct from the associated individuals like the deceased person, trustors, or beneficiaries.


